TDC GLOBAL ELECTION RULES AND REGULATIONS 2023

Introduction:

Tanzania Global Diaspora Council – TDC Global is preparing for its annual general meeting, the meeting which will include election for TDC Global Leaders (Chairperson, Deputy Chairperson, Secretary General, Deputy Secretary General , Treasurer) and members of the executive committee. The election process will start from 2nd May 2023 to July 2023 and will take place at TDC Global annual general meeting, which is to be held on 11th and 12th July 2023 in Tanzania as per final AGM program. Elected leaders will take their respective positions at the conclusion of the elections with acceptance speech of the elected Leaders

Rules and Regulations

1. The elections will involve TDC Global active members only (financial members) as per (TDC Global Constitution, # 10.1 a, b, and c.). Other registered - non active members and diaspora who are interested to be elected or elect leaders on this AGM, are reminded to register and pay their membership fees before 10 June 2023. Membership fees can be paid electronically using the following link: https://bit.ly/TDCGlobal_Membership_Fees.
2. Tanzanian Diaspora who are not TDC Global members, and wish to Join TDC Global, they are encouraged to register themselves on TDC Global website: www.tdcglobal.org/ and pay their respective membership fees electronically using the following link: https://bit.ly/TDCGlobal_Membership_Fees. This category of diaspora must complete their registration and payment process latest by 10th May, 2023 at 24:00 by Swedish time (GMT +2), or at 24:00 by Tanzanian time (GMT +3) to be able to participate in the elections and annual general meeting
3. The membership fees should be fully paid by all members from the first date they register themselves as TDC Global member starting 2019 in order to fulfil constitution request #10.1 a & c. Members who are not aware of their status of membership payments are advised to contact TDC Global Treasurer using email katibuhazina@tdcglobal.org to verify their status of payments. This will avoid any misunderstanding which may lead to loosing their active membership rights (financial member).
4. Treasury Secretary will also send the email to remind all members about their status of payments using email info@tdcglobal.org. The email should state the status of member from the date they joined TDC Global.



5. Application form (to contest various Leadership position) will be available on TDC Global website and can be downloaded by any interested parties from their TDC Global profiles. The application form can be also provided on request from TDG Global using email uchaguzi@tdcglobal.org. from 10 April 2023.
6. The applicant will be solely responsible to scan and send a copy of his/her filled application form, and submit it to TDC Global returning officer using email uchaguzi@tdcglobal.org by 10 May 2023. The original form has to be sent immediately to TDC Global. Box 1089, 10139 Stockholm, Sweden.
7. The Returning Officer will evaluate the candidates based on (TDC Global constitution # 10.1 a, b, and c. and TDC Global Constitutions #.13). Candidates will be arranged on the basis of the categories in accordance with the positions they applied for. The compiled list will be submitted by the Returning Officer to TDC Global secretary general for verification (ref:TDC Global #10.6) by the Executive Committee before publication.
8. Names of the candidates will be announced to the public through TDC Global social media between 1st to 5th June 2023. Objections if any, to the candidates have to be sent to Returning Officer using email: uchaguzi@tdcglobal.org within seven calendar days after the announcement. No objections will be accepted after 12th June 2023, 24:00 Swedish time(GMT +2), or at 24:00 Tanzania time (GMT+3)
9. The returning officer shall evaluate the objections and make rulling on the matter within 2 working days from from the closing date and time.
10. In case of any disagreement between the objector and returning officer, the matter can be referred by returning officer to TDC Global Executive Committee, which may establish a special committee to revised the issue. The decision of the special committee will be final on all election issues. The Decision will be sent back to the returning officer via executive committee for further election processes.
11. The final candidates list will be released to public, including TDCG Social Media on the 25 June 2023 by the returning officer. Candidates will have a period between 26 June to 05 July 2023 to campaign for the elections. The election campaign should be ethical with the respect of Tanzania traditions, as well as campaign rules as will be passed by the executive committee for good election to all.
12. The election will be done using prepared ballot pappers. The ballot papers will be prepared by the returning officer and approved by the Executive Committee. If the executive committee are all candidates in the current elections, then the executive committee will select a committee of 2 active members for the purpose of review and approve the ballot pappers and return to the returning officer for election purpose. The returning officer, may consult approved conference IT staff for the format of the Ballot Papers.



13. All candidate must be physically present at the AGM for elections, proxy's are not allowed. The candidate who fails to attend the AGM will be disqualified from the elections. In the event the candidate was the sole candidate, the position will be filled in a manner to be determined by the AGM.
14. The annual general meeting, will elect the meeting chairperson amongst the active members attending the AGM, before the election process commences. The meeting chairperson will supervise the selection of two tellers who will assist returning officer in the elections process and vote counting.
15. The voting will be done using ballot papers to elect the TDC Global leaders, as well the other members of the executive committee on 11/12 July 2023 as per AGM schedules. The returning officer and the two tellers will supervise the election, counting the vote and announce the winners and the runners-up at the AGM.
16. The decision of the majority shall be binding on all members of the TDC Global. This decision can not be overturned by anybody, except by a competent Court of Law.
17. The leaders with consultation of the newly elected executive committee, will make the selection of TDC Global standing committee leaders amongst the TDC Global active members. A selected list of leaders of the various standing committees should be completed not later than 30 August 2023.
18. The announcement will be issued to the public and members about showing interest to be selected to lead TDC Global standing committee, shortly after the elections of the leaders on the 11/12 July 2023.
19. The following positions will be available for any active member (financial members) to apply. (TDC Global constitution, elections rules and regulations are to be observed #13, a,b,c,d,f. g) for qualifications. The positions will be elected as follows.

A. Executive Committee Members

1. TDC Global Six (6) Member of Executive Committee

B. Leaders of TDC Global

1. TDC Global Treasury Secretary
2. TDC Global Vice Secretary General
3. TDC Global Secretary General
4. TDC Global Vice-Chairman/Chairperson
5. TDC Global Chairman/Chairperson (The 1st in order of acceptance speech).
